## Badin's Semi-Annual Town Clean-up is from Monday, April 9 through noon on Thursday, April 12.

We will pick up appliances, tires and rims (only if separated), furniture and cans of DRIED paint.

The town will not pick up cardboard or other items that are accepted at the convenience center.

If items should remain on the curb longer than seven days after the clean-up, you will be in violation of a town's ordinance and could possibly be cited.

Reminder: household trash and brush will not be picked up.

Separate items for clean-up as follows:

- Metal: rims appliances, bicycles, metal yard furniture, mowers, grills, heaters.
- General Household items: mattresses, furniture, webbed yard furniture, TV's, bird baths, cans of DRIED paint only.
- Construction debris: wood, landscaping timber, bricks.
- Rimless Ties.

## Badin Roads Paving Update

The good news is that three of Badin's roads are to be paved.

The bad news is that it will be possibly one or two years before it happens.

Nantahala and Boyden Streets will be paved sometime between June 2018 and June 2019.

Falls Road will be paved sometime between June 2019 and June 2020.

Meanwhile Badin traffic will just keep bumping along.

Five individuals have been named as defendants in a magistrate summons as well as complaints in summary ejectment, the preliminary documents for evicting persons from a place. First Man Management

is named in documents as the plaintiff with a list of five defendants headed by Bert Seale.

The case was dismissed at a Wednesday, March 28, 2018 court hearing as the defendants had already vacated the property in question, namely the Badin Inn.

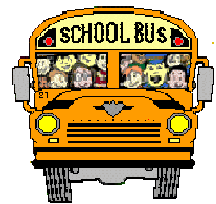
**Better Badin Golf Tournament Update:** Due to the closure of the Badin Golf Course, the tour-
